FROM THE PRINCIPAL

First off, I hope you all enjoyed the months away from school, our Michigan weather, and continue to be healthy. As I reflect upon the previous year, my priorities remain to keep Carleton Middle School a safe and supportive environment for all students to learn. The middle school years are often challenging, and I would encourage you to talk to your child about their social and emotional well-being, participate in school functions when possible, and monitor their grades/attendance while at school. In my experience, many issues arise when our students' electronic device usage and social media accounts are left unmonitored. Further, a variety of problems often develop when students are left unsupervised with unlimited access to the internet and social media. We need your support to ensure students succeed in their academic, behavioral, social, and emotional learning. If you need help or assistance, please rely on the school to be your partner to help your child learn, grow, and overcome any obstacles you may face. We are here, working alongside you to encourage and help your child develop, mature, and learn.

It is very important that you activate and use your Parent Portal account. This is the best way to stay informed and have access to what's happening at school. Please keep us updated about any email or phone number changes that occur during the school year. We regularly send out robo calls that go directly to your listed phone number and/or email if your permissions allow. Also, every Friday we send out a Carleton Chronicle highlighting what our students have been learning during the week. You may follow Carleton Middle School on Twitter @CarletonColts, Instagram @carletoncoltswcs, and our district website www.wcskids.net for families to access information. Additionally, our students and teachers use Schoology as a platform to access their work and a warehouse for assignments and assessments.

Carleton is a Title I building as determined through the Michigan Department of Education. Title I is a supplemental program from the federal government that provides funds to our school to help students achieve academic standards. We can provide our students with specific classes, learning opportunities, and access to resources that would not be available with state funding alone. It also means the staff at Carleton constantly evaluates the needs of our students and establishes rigorous goals in the areas of reading, writing, math, science, and social studies to benefit all of our students. The funds from the federal government help to establish and implement research-based programs to help our at-risk youth and to work with all stakeholders. Some of the programs in place because of Title I are Math Intervention Support, Reading Intervention Support, and summer enrichment opportunities. Under federal law, you as parents may request the following specific information about the professional qualifications of our children's teachers:

- 1) Whether the teacher has met the state qualifications/licensing for their grade level/subjects.
- 2) Whether the teacher is on a temporary permit or waiver.
- 3) The teacher's majors, graduate certificates/degrees, and discipline fields.
- 4) Paraprofessional services and qualifications.
